BLOOMINGDALE VOLUNTEER FIRE DEPARTMENT

Bill Latham said he is representing the Bloomingdale Volunteer Fire Department (BVFD) and submitted a letter to the Town Board regarding the fire hydrants. The BVFD would like to be notified when the water district will be flushing the hydrants around town, and this should be done twice a year. They would like to be involved so they can use this opportunity for a training exercise and would assist in flushing the hydrants. Bill said each hydrant should be flow tested every five years and each hydrant should be colored with paint to show fire personnel how much water in gallons per minute that the hydrant will flow. He gave a listing of color codes for each classification. Bill also said they request that the Town keeps all fire hydrants easily accessible at all times; winter, spring, summer, and fall.

BLOOMINGDALE VOL. FIRE DEPT. 2009 CONTRACT

Deputy Supervisor Grimone said the contract with the BVFD regarding the worker's compensation should be looked at with Essex County; they may have better pricing. Councilman Whitson said it was too late this year as they already paid for it; but it should be looked into for next year. Sam asked Bill Latham about the fuel for the fire trucks, if they are paying current price. Bill said they logged in every time but don't know the cost. Town Clerk stated that Connie does the figuring for their fuel and bills them. Town Clerk asked Bill to see if he could please get a copy of the 2008 and 2009 Fire Department budget for the Supervisor. She has requested one for several years and never received it. Bill said he will make sure to give them to her. Deputy Supervisor Grimone asked to tabled the Bloomingdale Fire Department contract and approve at the next meeting.

NORTRAX SERVICE QUOTE CONTRACT

Deputy Supervisor Grimone stated that with Roger and Joyce not in attendance tonight, he would like to table this until they are here. Town Board member unanimously agreed.

TRI-LAKES HUMANE SOCIETY

Deputy Supervisor Grimone said there were no changes in the contract wording, only the dollar amount that increased \$400.00.

HIGHWAY

Each board member has Roger's monthly highway report. Wells Communication put in the new two-way radio in the 2009 Mack truck. Roger had ordered some cold patch to fill the hole in the road by Normans; the State did give Roger five bags. The town's pick-up truck has repair problems and Roger took it to Bill McBride Chevrolet to have the transmission lines and the manifold fixed; the rest of the work was done in the town garage. Roger ordered a new compressor for the 2004 International. The 98 Loader is having steering problems and someone from Nortrax road service in Plattsburgh will come and check it out.

Deputy Supervisor Grimone said there needs to be Resolution of the 2009 Highway worker's budget for altering/amending the salary. The total increase for three highway workers is \$2,250 for the year. The money will come out of the highway equipment fund.

FRANK CASIER

Supervisor Morency received a letter from Francis Casier about a four acre parcel in Rockledge Park that does not have much market value. He has asked if the Town could have the Assessor reduce the taxes on the parcel or if the Town would be willing to accept a deed to this parcel; as it could be a park land. Deputy Supervisor Grimone said the taxes on this parcel are exceedingly high. John Jones asked how much it was assessed for and Sam said he didn't know. He asked to table this until further research has been done.

WATER & SEWER

Each board member received Bart's monthly Water & Sewer report. Deputy Supervisor Grimone said the transmission in the Water & Sewer truck has problems. Bart took it to Heath's for repairs and was told it is no good. They are looking for a used transmission to replace in the truck for approximately \$500.00. Councilman Jones said the truck must be at least ten years old. Sam said that Bart should be looking for a new or very good used truck. Councilman Dakin said that Bart should check out the State contract for the truck like Roger did with his truck; it may be a better deal. Councilman Whitson said even a used or new transmission in the truck is not much as the truck is old.

MT. PISGAH

Councilman Jones did attend the last Village board meeting to ask for a reduction in price for St. Armand's residents for fees at Mt. Pisgah. He said that after all he said to support the reduce fees; Village Trustee Branch said that Mt. Pisgah is always \$50,000 in the red each year and can't support reducing the fees for St. Armand's residents.

GENERATORS

Councilman Dakin set up for the generators to get serviced by Hugh Mullen of

Mullen's Engine Works. All of the generators have been serviced. Town Clerk said Hugh told her that next time all generators will need to have new filters. He did replace the oil filter in the generator at the Town Hall, as it is set to turn on every week for 30 minutes.

CELL TOWER

Deputy Supervisor Grimone stated that Joyce told him she has called Verizon and the permit for the Adirondack Park Agency still has not been submitted.

TOWN HALL EXPANSION

Deputy Supervisor Grimone asked the Town Board if they still want to purchase the lot next door and if so, there need to be a Resolution to have an appraisal done. Councilman Dakin said that the Willett's would like to know what the Town Board wants to do; either sell it to the Town or put the lot up on the market for sale. Councilman Dakin said he would speak to them after tonight's meeting. Councilman Whitson said that if the Town did buy the lot and not use it for the extension of the building; it could be for other uses such as expansion of the parking lot.
