NOTICE IS HEREBY GIVEN that there has been introduced before the Town Board of the Town of St. Armand, New York proposed Local Law No. 1 of the year 2010 entitled "A Local Law providing for the licensing of dogs, and the regulation of activities of dogs, in the Town of St. Armand, to be known as the "Dog Control Law of the Town of St. Armand."

The purpose of the proposed local law is to establish fees and procedures for the licensing of dogs within the Town of St. Armand, and to regulate the activities of dogs within said Town.

NOTICE IS FURTHER GIVEN that the Town Board of the Town of St. Armand will conduct a public hearing on the proposed Local Law on December 16, 2010 at 5:00 p.m. at the Town Hall, 1702 New York State Route 3, Bloomingdale, New York 12913.

Copies of the complete text of the proposed Local Law may be obtained prior to the public hearing by contacting the Town Clerk of the Town of St. Armand. At the time and place set forth above, all persons interested shall be given the opportunity to present their views on the proposed local law.

Immediately following the Public Hearing, there will be a Special Board Meeting for a resolution to adopt the new Dog Control Local Law #1 of 2010.

RESOLUTION #100 - "DOG CONTROL LAW OF THE TOWN OF ST. ARMAND"**

WHEREAS A Resolution of the St. Armand Town Board hereby adopts proposed Local Law No. 1 of 2010, entitled "Dog Control Law of the Town of St. Armand" providing for the licensure of

dogs within the Town of St. Armand and the running at large and other uncontrolled behavior of licensed and unlicensed dogs and protecting the health, safety and well being of persons located within the Town of St. Armand from physical harm or property damage which Local Law reads.
