Supervisor Morency called the meeting to order at 6:00 p.m.

The Pledge of Allegiance was led by Councilman Grimone.

The reading of the Public Notice was waived by Supervisor Morency.

Notice is hereby given that the Preliminary Budget for the Town of St. Armand for the fiscal year beginning January 1, 2012 has been completed and filed with the Town Clerk, 1702 NYS Route 3, Bloomingdale, New York 12913 where it is available for inspection by any interested parties.

Further notice is hereby given that the Town Board of the Town of St. Armand will meet and review said preliminary budget and hold a Public Hearing thereon at the Bloomingdale Town Hall at 6:00 p.m. on November 10, 2011. At such hearing any person may be heard in favor of or against any item or items therein contained or against the Preliminary Budget as compiled.

FIRE CONTRACT

Councilman Grimone asked what our fire budget is with the Village of Saranac Lake. Supervisor Morency stated the contract if for \$16,768.89. The fire rescue is \$2,700 for our share. The Bloomingdale Volunteer Fire Department is \$29,500 and one half of the Worker's Compensation is \$6,336. In the Bloomingdale Fire district, \$8,000 was put into the budget to cover repairs for the hydrants. North Elba Fire protection is \$6,750 up from \$6,000.

TAX RATE

Supervisor Morency stated that the tax rate is close to last year's. The 2012 inside town rate is 4.09475 compared to 4.10966 in 2011. The 2012 outside town rate is 4.46653 compared to 4.46984 in 2011. Mike Kilroy said that the inside rate dropped a penny, while the outside rate remained nearly the same.

Mike stated that if there are no changes at all, then the amount to be raised by tax will be 677,086. Supervisor Morency stated that there is no increase in taxes. The increase in revenue will be the pilot tax from AMA from 18,000 to 29,233; Essex County sales taxes 35,000, and the cell tower annual increase will be 14,400.

SALARIES

Nancy Heath stated that she does not think it is fair for the men to get 5 percent raises and the rest of us get nothing; it's a slap in the face. Councilman Grimone stated that he is totally opposed to anyone in this economy to get 5 percent; he just can't do it. The military personnel put their lives on the line and they are getting 1.6 percent for the next three years. Essex County workers are facing layoffs stated Supervisor Morency.

Councilman Jones stated that if the men get 5 percent, then everyone else get the same. Councilman Dakin stated that the Town gives them 100 percent benefits, and Councilman Grimone agreed. Nancy Heath stated that she pays 31 percent towards her medical (at other job), and the highway men don't pay anything.

Supervisor Morency stated that when the water and sewer department guy left, he left us in such a mess. The highway men have been doing work with the water and sewer problems and Jeff uses them to help him.

SALARY COMPARISON

Sandy Hayes stated that he has several towns with their highway superintendent salaries and the highway workers. He stated that Roger is overpaid, while the men are underpaid. Supervisor Morency stated that Roger spoke to her and said he is willing to forego a portion of the percentage so his men can have a higher raise.

Councilman Grimone stated that he is in favor of 3 percent raise for everyone and 1 percent for Roger. Chris Knight asked about the money for the raises. Mike Kilroy stated that he will take money out of the current budget and make it work. Supervisor Morency stated that if it does go higher, it will still be under the 2 percent tax cap.

WATER USAGE RATE

Mike Kilroy stated that the water usage rate is currently at \$3.25 per 1,000 gallons, and the new rate will be \$3.92 per 1,000 gallons; an increase of 67 cents. Supervisor Morency stated that the increase in the water budget will help pay for repairs, and there will be no increase in the sewer.

Supervisor Morency adjourned the Public Hearing at 7:30 p.m.

SPECIAL BOARD MEETING NOVEMBER 10, 2011

Supervisor Morency opened the Special Board meeting at 7:31 p.m.

The reading was waived by Councilmen Jones and Grimone.

Supervisor Morency asked for a resolution to accept the salaries as discussed.

Roger Oliver will receive a 1 percent raise.
