Supervisor Morency called the Special Board meeting to order at 5:00 p.m.

Supervisor Morency stated she needs a resolution approving the Bond Anticipation Note (B.A.N.) for \$57,931. Essex County Attorney Dan Manning sent the paperwork.

Councilman Dakin, who moved its adoption, offered the following resolution.

WHEREAS, the Town Board of the Town of St. Armand, Essex County, New York did on the 7th day of January, 2011 duly adopt a Resolution authorizing the issuance and sale of serial bonds of the Town of St. Armand in an amount not to exceed in the aggregate the sum of \$86,897 for the purchase of a 2010/2011 John Deer 544K Wheel Loader and Accessories; and

WHEREAS, on the 18th day of January, 2011 the Town of St. Armand did issue a Bond Anticipation Note in the amount of \$86,897 at an interest rate of 2.3% to mature on the 18th day of January, 2012 which Bond Anticipation Note was issued pursuant to a Bond Anticipation Note Resolution date the 7th day of January, 2011; and

WHEREAS, the Town of St. Armand it's desirous of paying the sum of \$28,966 on the principle amount of \$86,897 leaving a principle balance of \$57,931; and

WHEREAS, the Town of St. Armand now desires to issue and sell a Bond Anticipation Note Renewal in the amount of \$57,931; and

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of St. Armand, Essex County, New York.
