A lot of the water lines are plastic so they are having trouble locating them. They feel it is only going to take a couple of weeks for what they are doing now. Dean stated if the Board wanted to wait until the next meeting, that would be fine; he just wanted to get them the information. The Board determined they would like a chance to discuss it and make a determination at the next Board meeting.

Sandy Hayes asked who the person was in the County that took Charli Lewis' place. Dean was not sure. Sandy then asked when does the official swearing in of the new Town Supervisor take place and Dean Montroy responded it would be on Friday, May 3rd, at 12:01 pm.

Guest Victor Burman thanked Dean for the job he did during the time he served as Town Supervisor and thanked Davina for stepping up.
