WHEREAS, Father Peter Riani of St. Elizabeth's Church in Elizabethtown and St. Philips Neri Church in Westport will be retiring at the end of September leaving a big void in both parishes.

BE IT RESOLVED that the Essex County Board of Supervisors, its Clerk of the Board, County Manager and County Attorney hereby pause in its deliberations to congratulate Father Peter Riani upon his upcoming retirement and regretfully bids him good-bye as he leaves St. Elizabeth's and St. Philips Neri Churches; and

- **WHEREAS,** Nicholas Manfred, a 12 year old seventh grader at Moriah Central School won the Champlain Valley Educational Services Regional Spelling Bee in March to earn his spot in the 2012 Scripps National Spelling Bee in Washington, D.C.; and
- **WHEREAS,** Nicholas Manfred, at his first trip to the nation's Capitol, competed against 277 other top spellers from the United States, Canada, American Samoa, Guam, Puerto Rico, the U.S. Virgin Islands, the Bahamas, China, Ghana, Jamaica, Japan, New Zealand, Italy and South Korea; and
- **WHEREAS,** Nicholas Manfred participated in the first three rounds of the competition which consisted of a written test and two oral rounds with the two oral rounds being televised live; and
- **WHEREAS,** although he was eliminated and did not make it to the semifinals, Nicholas Manfred should be proud of himself for all of his accomplishments and for making it as far as he did.
- **BE IT RESOLVED** that the Essex County Board of Supervisors hereby extend their heartiest congratulations to Nicholas Manfred on a job well-done and for all of his accomplishments at the Regional Spelling Bee and at the 2012 Scripps National Spelling Bee; and

RESOLUTION COMMEMORATING THE 200TH ANNIVERSARY OF THE FIRST CONGREGATIONAL CHURCH - TOWN OF LEWIS

The following resolution was offered by Supervisor Blades, who moved its adoption.

Upon the recommendation of the Ways and Means Committee of this Body, and the same appearing proper and necessary.

WHEREAS, it is the intent of this Board to honor and commemorate the history of the First Congregational Church of Lewis and the proud heritage of the men and women that struggled to maintain this place of worship for 200 years; and

WHEREAS, for two centuries the Lewis Church has stood as a monument to the Reverend Cyrus Comstock, known as the father of Congregational Churches in Essex County. On June 12, 1812, Reverend Comstock, the inventor of the Comstock Wagon, met with a handful of people at the home of Dr. Alexander Morse in Elizabethtown, New York for the purpose of organizing a full time Congregational Church in Lewis, New York. Among those present were Deacon Levi Brown, a great grandfather of Thomas Brown; and

WHEREAS, a permanent structure of worship was started in 1823, but remained unfinished until 1834 and over the years many changes have been made to the church. When the church was finished in 1834, the membership of the church stood at 125 members; and

WHEREAS, upon return from a visit to northern Essex County in October 1852, Cyrus Comstock was thrown from his invention and died January 8, 1853 at 87 years of age and is buried in the northeast corner of the Lewis cemetery. A plain marble tablet inscribed with his name, date of birth and death with the words: He was the Father of Congregational Churches in this County, most of which were gathered by him as a missionary, a faithful minister, mark his grave; and

WHEREAS, on Tuesday, July 18, 1875, the Reverend Henry Ward Beecher was present at the church to preach the sermon to dedicate the rebuilding of the church. Over 200 people were in attendance and as the church could not hold that many, the service was held in a nearby grove. It was as a result of this service and the challenge that was offered that the entire debt of \$2,650.00 to redo the church was received in donations; and

WHEREAS, throughout the history of the First Congregational Church of Lewis, the church struggled with membership, operating expenses and finding pastors. At times the church was forced to share pastors with the Wadhams or Elizabethtown churches, or use lay preachers, and at times had to close during the frigid winters. The church has in the course of 200 years, experienced 59 different pastors at the pulpit, some being long term

and others for a few weeks. Membership of the church has been up and down depending on community needs and the ability of the ministers to engage new members or bring old ones back into the church; and

WHEREAS, in 1962, a celebration was held to recognize the 150th anniversary of the First Congregational Church of Lewis, with the history of the church throughout the first 150 years documented by Frederick Crossman in a publication. One of the most moving aspects of this anniversary celebration was the grave-side memorial service in honor of Reverend Comstock, the church founder; and

WHEREAS, over the years members have come forward to provide for maintenance of the church with paintings, stained glass windows, new rugs, bookcases, and an attached carriage port. To this day, it is the members that clean the church, shovel snow and take on the responsibilities of serving on church committees; and

WHEREAS, church members pursued a capital project in 1985 where they raised the funds and then built and furnished an attached Parish Hall to the church. The new parish hall was dedicated in June of 1989, at the same time Fred Shaw was offered a position as the pastor of the Lewis and Elizabethtown churches and currently holds the distinction of being the longest tenured pastor; and

WHEREAS, in 2005, the church was approved for listing on the National Register of Historical Places after a member wrote a successful nomination. The dedication of this occasion by a plaque was unveiled during the bicentennial of the Town of Lewis in August of 2005.

NOW, THEREFORE, BE IT RESOLVED, that the Essex County Board of Supervisors in its deliberations to commemorate the 200th Anniversary of the formation of the First Congregational Church of Lewis, recognize the long and fruitful history of this church and significance of the role it played in the Town of Lewis and in Essex County. This body understands that this is not the final chapter in the history of the church, but rather a continuation of the struggles that have been shared by the members from 1812 to the present; and

BE IT FURTHER RESOLVED, that a certified copy of this Resolution, suitably embossed, be transmitted to the First Congregational Church of Lewis.

This resolution was unanimously seconded, and adopted.

RESOLUTION AUTHORIZING A TRANSFER FROM THE GENERAL FUND TO THE DPW-HIGHWAY DEPARTMENT IN THE AMOUNT OF \$1 MILLION, AS A LOAN, INTO THE FLOOD REPAIR ACCOUNTS, WHICH LOAN FUNDS WILL BE RETURNED WHEN REIMBURSEMENT IS RECEIVED FROM FEMA AND OEM

BE IT RESOLVED that the Essex County Board of Supervisors hereby authorizes Ragnar Events to rent the Essex County Fairgrounds as a staging area for the Ragnar Relay to be held on September 28 & 29, 2012, and authorize the Chairman and/or County Manager to execute a contract with Ragnar Events, upon approval of the County Attorney; and

BE IT FURTHER RESOLVED that the Essex County Board of Supervisors hereby amends Resolution No. 314 of 11/7/2011 to also allow Ragnar Relay to use County Route 5, Alexandria Avenue in Ticonderoga and County Route 21, and River Road in North Elba as well as the County Court House parking lot for their event.

RESOLUTION REQUESTING GOVERNOR CUOMO AND THE STATE OF NEW YORK TO PROVIDE FUNDING FOR THE MAINTENANCE AND UPKEEP OF THE DETERIORATING WHITEFACE MOUNTAIN VETERAN'S MEMORIAL HIGHWAY IN WILMINGTON

The following resolution was offered by Supervisors Politi and Preston, who moved its adoption.

Upon the recommendation from the floor, and the same appearing proper and necessary.

WHEREAS, the Whiteface Mountain Veteran's Memorial Highway, extending from Wilmington, New York to the top of 4,867 foot Whiteface Mountain, was the collaborative effort of Governors Smith, Lehman and Franklin Delano Roosevelt having opened in 1936; and

WHEREAS, the Whiteface Mountain Veteran's Memorial Highway was dedicated in 1929 to the veteran's of all wars of the United States; and

WHEREAS, during the past decade, the roadway and its shoulders, beginning at the toll house and extending to the summit of Whiteface Mountain, have deteriorated and failed to such an extent that the road has become patently dangerous to motorists and, more particularly, to motorcyclists and cyclists who use the road; and

WHEREAS, in 1983, the New York State Department of Transportation stopped regular maintenance on the road and, upon information, no major improvements to the roadway, its shoulders and culverts have been done for several years; and

WHEREAS, approximately two years ago, the New York State Department of Environmental Conservation prepared an engineering study relative to the repair and maintenance of the road which resulted in an estimated cost of approximately \$4.5 million, however no major repairs were made; and

WHEREAS, the Whiteface Mountain Veteran's Memorial Highway is one of the scenic crown jewels of the State of New York providing the public with easy access to the top of Whiteface Mountain and is one of the only handicapped accessible mountain tops in New York State and most of the Eastern United States; and

WHEREAS, this Board of Supervisors is acutely concerned with the present condition of the roadway as the failure to repair and maintain the roadway will result in more damage to the road and shoulders and perhaps impede tourism as well as pose immediate

and imminent danger to motorists and cyclists; and

WHEREAS, to continue to neglect the maintenance and repair of this roadway for well over a decade is unacceptable and dangerous.

BE IT RESOLVED that the Essex County Board of Supervisors strongly, and with adamance, requests that the State of New York, the New York State Department of Environmental Conservation, the New York State Olympic Development Authority and the New York State Department of Transportation, provide sufficient funding to repair the deteriorated and dangerous road beginning from the toll house to the summit of Whiteface Mountain to protect and preserve the roadway and its shoulders and to provide safe passage to the motoring public, as to continue to unfund and ignore this situation for such an extended period of time is a travesty as well as a danger; and

BE IT FURTHER RESOLVED, that this Board strongly urges the State of New York and these departments to continue to fund, repair, maintenance and upkeep of the Whiteface Mountain Veteran's Memorial Highway in the future to preserve this asset and avoid dangerous conditions; and

BE IT FURTHER RESOLVED that the Clerk of the Board be, and hereby is, authorized and directed to forward copies of this resolution to Governor Andrew Cuomo, Senate Majority Leader Dean Skelos, Senator Elizabeth O'C. Little; Assembly Speaker Sheldon Silver, Assemblywoman Teresa Sayward, and Assemblywoman Janet Duprey; New York Department of Environmental Conservation, New York State Department of Transportation and ORDA.

This resolution was unanimously seconded and adopted.

RESOLUTION AUTHORIZING TO GO TO BID OR RFP FOR APPROVED FEMA DEBRIS REMOVAL TO BE BASED ON PROJECT WORKSHEETS AND FURTHER AUTHORIZING AN INTER-MUNICIPAL AGREEMENT WITH ALL TOWNS WHO PARTICIPATE IN THE DEBRIS REMOVAL

The following resolution was offered by Supervisor Ferebee, who moved its adoption.

Upon the recommendation from the floor, and the same appearing proper and necessary.

WHEREAS, the County of Essex has received a grant from the New York State Department of Environmental Conservation incident to debris collection, removal and disposal relative to the Hurricane Irene disaster; and

WHEREAS, various Towns within Essex County have also received FEMA funding relative to debris removal and disposal; and

WHEREAS, it is the intention of Essex County and the various Towns within the County who have received the grants to enter into an inter-municipal agreement relative to the collection and disposal of all debris resulting from Hurricane Irene with Essex County to solicit bids and/or RFPs for debris removal based upon individual project work agreements and with the various Towns to reimburse and pay Essex County for work done under the Essex County debris removal contract.

BE IT RESOLVED that the Essex County Board of Supervisors hereby authorizes its Purchasing Agent to go to bid and/or solicit RFPs for debris collection and removal and to award the contract to the lowest responsible bidder/proposer for such work throughout the County of Essex and the various Towns and authorizes the County Manager and/or Essex County Board of Supervisors Chairman to execute such contract subject to the approval of the County Attorney; and

BE IT FURTHER RESOLVED that the Essex County Board of Supervisors hereby authorizes the County of Essex to enter into an inter-municipal agreement pursuant to Section 119-0 of the General Municipal Law with the various Towns within Essex County participating in the debris removal program wherein and whereby the Towns will individually pay for debris collection, removal and disposal in their Town as set forth in the project work agreement and other pertinent documents.
