- Regarding Drawing N-1: General Notes Note 11 at the end of the note, ADD the following:
 - "E. Lead Exposure Control Plan"
- 4. **Regarding Drawing N-1:** Painting Notes Note 8 at the end of the note, ADD the following:
 - "All lead paint removal work shall be completed in accordance with the requirement of NYS Department of Transportation Standard Specification Section 570. Containment shall be Class A or Class B depending on the contractor's proposed method for paint removal."
