SUBJECT: Addendum #2 RADIO SYSTEM MAINTENANCE

This Addendum, issued to bid document holders of record, indicates three (3) changes to the bid documents for the *RADIO SYSTEM MAINTENANCE* Bid Opening May 27, 2015.

#1 Under Section II. Technical Requirements, Subsection II.2.1, Operations Requirements, add the following bold text to Number 1:

- 1. The SELECTED CONTRACTOR shall be fully responsible for ensuring that Network operations meet or exceed Alcatel-Lucent's specification of 99.999% availability (uptime), with less than 5.26 minutes per year of downtime during the initial two years of contract with the SELECTED VENDOR. All network outages shall be tracked and reported by the SELECTED VENDOR. Outages due to atmospheric conditions shall be reported separately and distinctly than other outages.
- #2 Replace the PROPOSAL form with the attached PROPOSAL form (3 pages).
- #3 Supplemental information for Bidders as a result of the Bidders Conference held on May 7, 2015: The County has purchased from Alcatel-Lucent Remote Technical Support (RTS) Bronze (8 AM to 5 PM Central) for the MDR-8000radios and the one (1) year of Alcatel-Lucent Internet Protocol Division (IPD) RTS Gold support (24x7) for the 7705 Site Aggregation Routers (SARs).
