PRE-BID MEETING MINUTES ASBESTOS ABATEMENT @ FISH HATCHERY

The pre-bid meeting was held on Friday 6/10/16 at the Fish Hatchery location.

The meeting was administered by Jim Dougan, Assistant civil engineer / Deputy Superintendent of the Essex County Department of Public works, all bidders were asked to sign in, the sign in sheet is attached.

The bidders walked through each structure.

Question: The bidders spent significant time looking at the former residence building and suggested that it might be less expensive to demolish and dispose of the entire building as asbestos containing as the foundation coating removal and soil clean-up would likely be more expensive to abate than to demolish.

Answer: As a part of the addendum please find a revised bid form, which includes an alternate to remove the entire residence structure as non-friable asbestos containing rather than just abating the identified materials. Include in this cost the cost of any variances necessary from NYSDOL.

Question: The bidders asked the rating of the bridge.

Answer: The bridge is HS20 load rated.

Due to the addition of an alternate bid item, the bid date will be extended to Friday 6/24/16.
