In addition to bid sheets, the bidder shall submit executed non-collusion bid certificates signed by the bidder or one of its officers as required by the General Municipal Law Sec. 103d. The bidder shall also submit an executed certificate of compliance with the Iran Divestment Act signed by the bidder or one of its officers as required by the General Municipal Law Sec. 103g.

The Town intends to purchase three (3) systems with payment made as follows:

- 20% after approval of submittals and release for manufacturing, less 5% retainage
- Additional 50% (total of 70%) after delivery of treatment units to site, less 5% retainage
- Additional 30% (total of 100%) after completion of treatment unit start-up, less 5% retainage
- Final 5% retainage payment made upon Engineer's receipt and satisfactory acceptance of treatment units
