## A scheduled pre-bid meeting was held for the above referenced project on March 2, 2021 at 9:00AM at the project site. The following items were discussed:

- 1. ES provided a general summary of the overall scope of work for the project:
  - This is a local Essex County funded project with two separate bids. One bid is for the design, manufacture, and delivery of the pre-cast units (three-sided culvert units and wing wall units), and the second bid is for the construction of the project including installation of the pre-cast units.
  - Both bids are based on a lump sum contract.
  - The road will be closed during construction and another bridge replacement project (Tracy Road over Ash Craft Brook) will be ongoing at the same time located 0.4 mile east. It is intended to work out a schedule such that one project will be constructed after the other so that construction traffic may pass over New Pond Brook during the construction at Ash Craft Brook and vice versa. The details of the schedule will be coordinated following the award of both projects.
  - Permits are in the process of being issued from USACE and NYSDEC (Stream Alteration and Temporary Revocable Permit). Copies of issued permits will be provided once available.
- 2. A question was asked whether drawings of the existing bridge structure are available. BL indicated that if any drawings are available, they will be provided by Addendum.

The meeting adjourned at approximately 9:30 AM.
