- 8. The successful bidder will be required to provide Performance and Payment Bonds in an amount equal to 100% of the contract value.
- 9. Low bidder(s) may be required to provide a statement of contractor qualifications.
- 10. This is a prevailing wage rate project. Contractors are required to pay subcontractors and workers per the prevailing wage rate determination included.
- 11. Discuss M/W/BE and SDVOB Goals
  - This is a county funded project so the use of M/W/BE and SDVOB is not required but the county encourages contractors to seek and use where fit.
- 12. Discussion of Stormwater Pollution Prevention and Erosion control

### 13. Discussion of Permits

- It will be the contractor's responsibility to obtain any permits necessary to complete the project.
- 14. Contract questions and answer period.
  - NOTE: The building is currently not hooked up to the sewer, so drains for the washup station would need to be run to a nearby sewer cleanout. There is power and water on site.
  - NOTE: The doors noted "Black Door Lite Butyl Associated with Metal Door" shown on drawing #2 of the survey will need to be abated in place, the door cannot be removed permanently. All other doors marked as asbestos containing can be removed from there hinges and disposed of.
