JOB SUMMARY: The work involves responsibility for performing professional engineering tasks of a moderately difficult caliber involving exercise of engineering judgment on a variety of projects. The employee may be in charge of projects in the field or of the design of projects in the office, or in some special phase of engineering or public works activities both in the field and office. Assignments are received from the County Highway Superintendent who outlines the scope of work to be performed, although the incumbent uses independent judgment in planning work details and making engineering decisions on routine problems. An incumbent gives advice, instruction and supervision on difficult technical problems to construction foremen and crew members. The incumbent does related work as required.

MINIMUM QUALIFICATIONS: Either:

- (a) Possession of a Bachelor's Degree in Civil Engineering and two years of engineering experience; or
- (b) Possession of an Associate's Degree in Civil Engineering Technology or a related technical field and four years of experience in engineering, construction planning or related technical field; or
- (c) Graduation from high school or possession of a high school equivalency diploma and eight years of experience assisting in engineering or construction planning or related technical field; or
 - (d) An equivalent combination of training and experience as defined by the limits of (a), (b) and (c).
