## INSTRUCTIONS ALL APPLICATIONS MUST BE HANDLED THROUGH THE MAIL

It is your responsibility to contact the court to let them know that you are applying for a reduction and request a 30 day adjournment of your court date- this Office **cannot** grant adjournments. You may be required to send in a "not guilty" plea while your plea reduction request is being considered. It is your responsibility to ask the Court if you need to enter this "not guilty" plea while you wait for a response from our Office.

Your application will only be processed if the following documents are provided. If you fail to follow these directions, your application for a reduction will not be considered and you will not receive a response. It is your responsibility to follow up with the Court if you do not receive any documentation from this Office within the 30 day period. If you fail to provide this Office with a self-addressed stamped envelope, any response from this office will be sent directly to the Court and you will have to contact the Court for the People's decision.
