DISTINGUISHING FEATURES OF THE CLASS: A Data Officer's primary function is to gather data and prepare reports. The incumbent will be required to collect data and provide regular reports to the Office of Indigent Legal Services and Administration. The incumbent will work directly with the department head to establish caseload standards, define quality control measures and report on accountability. The purpose of this position is to support improvement of indigent criminal defense throughout the state and address funding issues that have impacted such work. The incumbent will work under the direct Supervision of the Public Defender. The incumbent will perform all related duties as required.
