JOB SUMMARY: This position involves responsibility for providing emergency medical services to residents of Essex County. The incumbent operates specially equipped medical vehicles in the transport of victims to area hospitals. The incumbent, possessing the appropriate certification level from the New York State Department of Health required for the position, renders initial medical services to people requiring medical assistance. The work is performed under general supervision with considerable leeway in the exercise of independent judgement in carrying out the details of the work. Supervision is exercised over Emergency Medical Technicians. Employees are required to rectify on a periodic basis the Advanced Emergency Medical Technician certification required for the position. The incumbent does related work as required.

MINIMUM QUALIFICATIONS:

- (A) Possession of a current certification from the New York State Department of Health as a Paramedic and must keep current throughout employment.
- (B) Possession of a valid license to operate a motor vehicle in New York State, appropriate for the vehicle to be operated.
- (C) Possession of a current Advanced Life Support certification within 6 months of hire date and maintain throughout employment.
- (D) Possession of CPR Certification that must remain current throughout employment.
- (E) Possession of an Emergency Vehicle Operation and Training certificate within one year of hire date.

Residency Requirement: There is no residency requirement.
