VACANCY: Essex County Department of Mental Health

SALARY: \$27.66/HR. (Hired PRIOR 2009); \$24.90/HR. (Hired AFTER 2009)

DISTINGUISHING FEATURES OF THE CLASS:

The work involves responsibility for performing assigned psychiatric social work services in a psychiatric out-patient clinic; the position involves ordinary responsibility for making case studies and for carrying through planned treatment with patients (both children and adults) with parents or related persons and with collateral agencies. The incumbent does related work as required.

Note: In compliance with OSHA, this position has a potential risk of exposure to bloodborne pathogens (blood/body fluids).

MINIMUM QUALIFICATIONS: Either:

- (A) Graduation from an regionally accredited or New York State registered college or university with a Masters Degree in Social Work and currently licensed as a Licensed Masters Social Worker (LMSW) or as a Licensed Clinical Social Worker (LCSW) by the New York State Education Department; or
- (B) Graduation from a regionally accredited or New York State registered college or university with a Masters Degree in Mental Health Counseling, Psychology, Human Services or related field and currently licensed as a Licensed Mental Health Counselor (LMHC) or with a Limited Permit to Practice Mental Health Counseling by the New York State Education Department; or
- (C) Graduation from an regionally accredited or New York State registered college or university with a Doctorate degree in Psychology and currently licensed as a Psychologist by the New York State Education Department; or
- (D) An equivalent combination of training and experience as defined by the limits of (a), (b), and (c).
