DISTINGUISHING FEATURES OF THE CLASS: The work involves responsibility for the organization and implementation of educational efforts regarding public health needs. Employees survey public health education needs and organize workshops, forums, and discussion groups to meet those needs. The incumbent is responsible to align activities with the Community Health Assessment. The work is performed under the general supervision of the Public Health Director/Director of Patient Services with leeway allowed for the use of independent judgment in carrying out the details of the work. The incumbent does related work as required.

MINIMUM QUALIFICATIONS: Either:

- (a) Graduation from a regionally accredited or New York State registered college or university with a Baccalaureate degree in health education, health science, public health, health promotion, community health, or health communications; or
- (b) Graduation from a regionally accredited or New York State registered college or university with a Baccalaureate degree in education, nursing, epidemiology, wellness and fitness, or nutrition and one year of experience in health education; or
- (c) Graduation from a regionally accredited or New York State registered college or university with a Baccalaureate degree in marketing, human services, social work or psychology and two years of experience in health education; or (d) An equivalent combination of training and experience as defined by the limits of (a), (b) and (c).

A local public health educator must satisfactorily complete 15 hours of continuing education in health education related topics approved by the New York State Department of Health within one year of appointment.
