JOB SUMMARY: The work involves responsibility for the fabrication or painting of various types of signs as well as the performance of miscellaneous tasks relating to sign construction, installation and maintenance in accordance with State regulations. The work involves laying out, lettering, painting and installing various traffic control signs and highway marking. The work is performed under the general direction of the General Highway Supervisor with leeway permitted for the exercise of independent judgment in carrying out assignments. Supervision is exercised over the work of a small number of Laborers. The incumbent does related work as required.

MINIMUM QUALIFICATIONS: Either:

- (a) Possession of an Associate's Degree in Engineering Technology or related field and two years of experience in traffic sign fabrication and maintenance; or
- (b) Graduation from high school or possession of a high school equivalency diploma and four years of experience as defined in (a); or
- (c) An equivalent combination of training and experience as defined by the limits of (a) and (b).

PROMOTIONAL QUALIFICATIONS: Three years of permanent status as a Construction Equipment Operator or one year as a Public Works Maintenance Supervisor.

SPECIAL QUALIFICATIONS: Possession of a New York State Class B CDL or higher at time of appointment.
