JOB SUMMARY: This is an administrative position responsible for coordinating and implementation of all components of the Women, Infants and Children (WIC) program with the objective of delivering supplemental food services and education in proper nutrition to women, infants and children eligible for the program. The work is carried out in accordance with State and Federal guidelines and regulations, and Department policies. Work is performed under the general direction of the Public Health Director with considerable leeway allowed for exercise of independent judgment in carrying out details of the work. Supervision is exercised over a small professional and clerical staff. The incumbent does related work as required.

Note: In compliance with OSHA, this position has a potential risk of exposure to blood borne pathogens (blood/body fluids).

MINIMUM QUALIFICATIONS: Either:

- (a) Possession of a Master's degree in Nutrition [Nutritional Sciences, Community Nutrition, Dietetics] or a related field: or
- (b) Possession of a Bachelor's Degree in Nutrition [Nutritional Sciences, Community Nutrition, Dietetics] or a related field and one year of Supervisory experience involving program management or supervision in a Public Health Agency or Community Based Organization; or
- (c) Completion of a Dietetic Internship in an institution approved by the American Dietetic Association and either be currently registered or eligible for registration by the American Dietetic Association with two years of supervisory experience involving program management or supervision in a Public Health Agency or Community Based Organization; or
- (d) An equivalent combination of training and experience in (a), (b) and (c).

SPECIAL REQUIREMENT FOR ACCEPTANCE OF APPLICATION: Possession of a current, valid New York State Driver's License at the time of appointment. License must be maintained throughout employment.

People seeking employment with Essex County shall be required to submit to a drug and alcohol screening/testing, pre-employment physical, and additionally may be required to submit to a fingerprint background check, depending upon the specific requirements of the position.
