This position exists in the County Health Department and involves responsibility for **IOB SUMMARY:** administering the nutrition components of the WIC program, a supplemental food and nutritional education program for women, infants and children who are low income and at nutritional risk due to medical problems or inadequate dietary intake. The position involves assessment of nutritional needs of clients, planning for the provision of a food package and counseling appropriate to the individual's physical, medical and emotional needs, and providing nutrition education to adequately meet their regular and therapeutic needs. The work is performed under the general supervision of the WIC Program Coordinator with leeway allowed for the exercise of independent judgment in carrying out the professional nutrition details of the job. Supervision is exercised over the work of WIC Nutrition Aides and other staff involved with nutritional aspects of the program. The incumbent does related work as required.

Note: In compliance with OSHA, this position has a potential risk of exposure to bloodborne pathogens (blood/body fluids).

## MINIMUM QUALIFIATIONS: Either:

- (a) Possession of a Bachelor's Degree in Nutritional Sciences, Community Nutrition, Clinical or Human Nutrition, Dietetics, Foods and Nutrition, or Public Health Nutrition; or
- (b) Completion of a Dietetic Internship in an institution approved by the American Dietetic Association and either be currently registered or eligible for registration by the American Dietetic Association.
