### ASSISTANT DIRECTOR OF NURSING

DISTINGUISHING FEATURES OF THE CLASS: The work involves responsibility for planning, directing and supervising activities as they apply to nursing services in the absence of the Director of Nursing. Plans and directs the facility's in-service training program. Plans, directs, and supervises nursing activities on the Health Related Unit. Work is performed under administrative direction of the Director of Nursing and Facility Administrator with leeway allowed for the exercise of independent judgment carrying out details of the work. The incumbent does related work as required.
