PUBLIC HEALTH INTERN

DISTINGUISHING FEATURES OF THE CLASS: Public Health Intern will be provided work assignments that are designed to provide a real world opportunity to work side-by-side with professional staff committed to teamwork and providing quality municipal services. An incumbent in this class will generally be expected to perform research and special projects as necessary. This is a unique opportunity to gain hands-on and in-depth experience in a wide variety of disciplines related to local, regional, state and federal governmental operations. Candidates meeting the minimum qualifications for the internship program may be appointed to serve on a temporary basis. Public Health Interns will generally be appointed on a temporary basis not to exceed six months. Interns work under the direct supervision of assigned professional staff. Supervision of others is not required. The incumbent will perform all related duties as necessary.

<u>TYPICAL WORK ACTIVITIES</u>: (Illustrative only)

May perform COVID Contract Tracer as a non-licensed public health professional providing support to a health department in the fight against COVID-19; May make contact with people who have been exposed to COVID-19 and provide health education and guidance to interrupt ongoing disease transmission;

Participate in requisite trainings, regular program meetings and quality monitoring improvement activities in order to ensure and enhance the quality of contact notification activities and program outcomes;

Maintain patient confidentiality and ensure that all information is collected in accordance with local data privacy and confidentiality standards;

Utilize a computer, tablet and/or cell phone with appropriate access to required applications, databases, and/or web-based platforms daily;

Performs research and special projects as assigned;

Assists professional staff with the performance of their duties;

Performs routine clerical duties in support of research and special projects as necessary; May be required to attend committee meetings in order to learn about committee structure and function;

May be required to provide committee support;

May be required to report on committee topics.

perform close detail work; ability to develop effective working relationships and deal diplomatically with the public and with co-workers; ability to understand and follow simple oral and written directions; strong verbal and written communication skills; physical and mental condition commensurate with the demands of the position.
