"ESSEX COUNTY LOCAL LAW NO. 1 OF 2022

A local law fixing the 2022 salaries of County officers who are elected or who are appointed for a fixed term.

BE IT ENACTED by the Board of Supervisors of Essex County as follows:

§1. The annual salaries during fiscal year 2022 for the following County officers who are elected or who are appointed for a fixed term shall be as follows:

This local law shall take effect 45 days after adoption hereof; except that in the event a valid petition protesting against this local law is filed with the Clerk within 45 days of such adoption, this local law shall take effect only upon approval by the affirmative vote of a majority of the qualified electors of Essex County."


