

**RESOLUTION AUTHORIZING THE RELEVY OF UNPAID ROAD, GARBAGE,  
WATER AND SEWER RENTS, AND VILLAGE AND SCHOOL TAXES**

The following resolution was offered by \_\_\_\_\_, who moved its adoption.

Upon the passage of a motion to consider from the floor, and the same appearing proper and necessary.

WHEREAS, the Supervisors of the several Towns within Essex County have transmitted to the Clerk of the Board the amounts of unpaid road, garbage, water and sewer rents on the 2019 tax rolls; and

WHEREAS, the Board of Trustees of the several villages and several school districts within Essex County have transmitted to the Essex County Treasurer the amounts of unpaid village and school taxes, duly verified and certified as provided by Real Property Tax Law Sections 1442 and 1330: and

WHEREAS, the unpaid village and school taxes are subject to relevy and collection pursuant to resolution heretofore duly adopted by this Board.

BE IT RESOLVED that the Clerk of this Board is hereby authorized and directed to relevy [a] any and all unpaid road, garbage, water and sewer rents on the 2019 tax roll, with the said amounts having been transmitted to the Clerk of the Board by the several town supervisors of the County of Essex in which towns said unpaid charges have occurred, and pursuant to Real Property Tax Law Sections 1442 and 1330 the amount of returned delinquent village and schools taxes certified as aforesaid and which remain due and unpaid as of close of business on December 8, 2018 together with an additional seven percent [7%] thereon; and said amounts shall be and hereby are assessed against and levied upon lands of several towns in the County upon which the same were imposed for collection therefrom as follows:
